ADOPT A RESOLUTION TO MAKE APPLICATION FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FOR THE PURPOSE OF PERFORMING ELIGIBLE COMMUNITY DEVELOPMENT ACTIVITIES THAT WILL BENEFIT THE RESIDENTS OF THE CITY OF KINGSTON

A motion made by Councilman Byrkit, second by Councilman White to adopt Resolution #15-1-13-1, to apply for a Community Development Block Grant (CDBG) funds for the purpose of performing eligible community development. The motion passed with a unanimous roll call vote. 6 Ayes

RECOMMENDATION TO THE COUNTY EXECUTIVE FOR THE APPOINTMENT OF VICE MAYOR TONY BROWN TO THE E-911 BOARD

A motion made by Councilman White, second by Councilman Childs to send a letter of recommendation to Roane County Executive Ron Woody requesting that Vice Mayor Tony Brown be appointed to a term on the E-911 Board. The motion passed with a unanimous roll call vote. 6 Ayes

APPROVE AND AUTHORIZE THE MAYOR TO EXECUTE THE INTERLOCAL AGREEMENT BETWEEN THE ROANE COUNTY HIGHWAY DEPARTMENT AND THE CITY OF KINGSTON

A motion made by Councilman White, second by Councilman Byrkit to approve and authorize Mayor Neal to execute the Interlocal Cooperation Agreement with the Roane County Highway Department. The motion passed with a unanimous roll call vote. 6 Ayes

A motion made by Councilman Byrkit, second by Councilman Childs to adjourn the meeting passed with a unanimous voice vote.
