The Regular Meeting of the Kingston City Council was held on Tuesday, March 9, 2015 at 7:00 p.m. in the Kingston City Hall. Mayor Neal called the meeting to order with Vice Mayor Brown giving the invocation and councilman Childs leading the pledge. Upon roll call the following members were present: Vice Mayor Brown, Councilman Byrkit, Councilman Childs, Councilwoman Humphreys, Councilman Sugarman, Councilman White and Mayor Neal. APPROVAL OF PREVIOUS MINUTES

A motion made by Councilman Sugarman, second by Councilman Byrkit to waive the reading and approve as written the minutes of the regular meeting on February 10, 2015. The motion passed with a unanimous roll call vote. 7 Ayes

A motion made by Councilman Sugarman, second by Councilman White to approve and authorize the mayor to execute the Automatic Aid Agreement between City of Kingston and City of Harriman. The motion passed with a unanimous roll call vote. 7 Ayes

SEND A LETTER OPPOSING THE AMENDMENT TO STATE HOUSE BILL 850

A motion made by Vice Mayor Brown, second by Councilman White to have the city manager send a letter to Rep. Calfee and Sen. Yager opposing the amendment to House Bill 850 concerning maximum gross weight of freight vehicles on county roads and bridges. The motion passed with a unanimous roll call vote. 7 Ayes

A motion made by Councilman Byrkit, second by Councilman Childs to adjourn the meeting passed with a unanimous voice vote.


Mayor Neal adjourned the meeting.
