# REGULAR MEETING KINGSTON CITY COUNCIL TUESDAY, JANUARY 9, 2018 – 6:00 P.M. KINGSTON CITY HALL

The Kingston City Council met in regular session on Tuesday, January 9, 2018 at 6:00 p.m. Mayor Neal called the meeting to order. Council Member Brown gave the Invocation and Vice Mayor Childs led the pledge. Upon roll call the following members were present: Council Member Brown, Vice Mayor Childs, Council Member Humphreys, Council Member Stockton, Council Member White, Council Member Wright, and Mayor Neal. Staff present: City Manager David Bolling, Finance Director Carolyn Brewer, City Clerk Marsha Marshall, and City Attorney Jack McPherson.
