## **RESOLUTION NO. 18-4-10-1**

A RESOLUTION TO AUTHORIZE THE CITY OF KINGSTON TO PARTICIPATE WITH ROANE COUNTY IN JOINT BIDS IN DELINQUENT TAX SALES AND TO AUTHORIZE THE EXECUTION OF AN AGREEMENT TO FORMALIZE THE ARRANGEMENT TO DEAL WITH PROPERTY ACQUIRED AT THE TAX SALE

WHEREAS, City Council of the city of Kingston deems it to be in the best interest of the city of Kingston and the citizens thereof to enter into an agreement with Roane County to participate in the tax sales and deal with the property acquired by the governmental entities at such sale.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KINGSTON that the Mayor be authorized to execute the Joint Bid Agreement attached hereto as Exhibit A.

# JOINT BID AGREEMENT BETWEEN ROANE COUNTY AND THE CITY OF KINGSTON FOR DELINOUENT PROPERTY TAX SALE

WHEREAS, Tennessee Code Annotated §67-5-2508 allows Roane County ("County") and the City of Kingston ("City") to jointly bid at delinquent tax sales and authorizes the execution of all contracts necessary or incidental to such joint bids; and,

WHEREAS, the Roane County Board of Commissioners resolved, by Resolution 10-19,-24 to authorize the County to participate in joint bids with the City of Kingston and to authorize the County Mayor to execute all contracts and all other documents necessary or incidental to the bidding and purchase of properties concerning both County and City delinquent taxes; and,

WHEREAS, the City Council of the City of Kingston resolved, by Resolution 18-4-10-1, to authorize the City to participate in joint bids with Roane County and to authorize the City Mayor to execute all contracts and all other documents necessary or incidental to the bidding and purchase of properties concerning both County and City delinquent taxes; and.

WHEREAS, the opening governmental bid at a delinquent tax sale must represent the amount needed to pay all property taxes, penalties, interest, and costs of collection that are a lien on any parcel of property offered for sale, including not only delinquent, but also current year taxes.

## NOW, THEREFORE, the County and City agree as follows:

- 1. At all delinquent tax sales, the Roane County Clerk and Master shall offer the each parcel of property wherein delinquent taxes are owing to the City and/or the County for no less than the amount needed to pay all property taxes, penalties, interest, and costs of collection that are a lien on any parcel of property offered for sale, which may include not only delinquent, but also current year taxes.
- 2. In the event no bid sufficient to pay all amounts set out in Paragraph 1 hereof is made, the Roane County Clerk and Master, acting for the tax entity or entities prosecuting the suit, shall bid the debt ascertained to be due for taxes, interest, penalties, and the costs and fees incident to the collection thereof, where no other bidder offers the same or larger bid; provided, that, when the legislative body of a tax entity determines that the environmental risks are such that it is not in the best interests of the tax entity for a minimum bid to be offered at the tax sale, the clerk shall not offer a bid on the property at the tax sale. In the event any such joint bid is the highest bid, the County and City shall both promptly pay their aliquot share of the bid amount to the Clerk and Master and shall take title to such property as tenants in common in proportion to their respective payments.
- 3. For all property acquired by the City and County as tenants in common pursuant to this agreement, the City and County shall each bear the reasonable and necessary costs associated

with the maintenance of said property and the risk of loss associated with said property in proportion to their respective ownership interests.

- 4. After the period of redemption has elapsed, the County shall arrange for the disposition of every parcel of property pursuant to T.C.A. 67-5-2507 utilizing the current bid procedures for the benefit of the joint owners.
- 5. From the sale proceeds, the County will distribute the gross sale proceeds in accordance with the proportionate ownership of the City and the County.
