ORDINANCE NO.	18-9-11-1

AN ORDINANCE OF THE CITY OF KINGSTON, TENNESSEE ADOPTING THE 2018 EDITION OF THE INTERNATIONAL BUILDING CODE (IBC) AND RELATED CODES

WHEREAS, the city council of the city of Kingston has heretofore adopted the International Building Code, 2006 edition, as and for the building code for the city; and;

WHEREAS, the International Building Code, 2018 edition, is a new standard which is recommended for adoption, and;

WHEREAS, the 2018 International Building Codes (IBC), and other codes as described herein provide for: regulating and governing the construction, alteration, movement, enlargement, replacement, repair, equipment, location, removal and demolition of all property, buildings and structures; the standards for supplied utilities, facilities and other physical things and conditions essential to ensure that structures are safe, sanitary, and fit for occupancy and use; the condemnation of buildings and structures unfit for human occupancy and use; the demolition of such structures as well as providing for the issuance of permits and collection of fees therefore; and,

WHEREAS, the city council finds that it is in the best interest of the city and its citizens to adopt the 2018 International Building Codes (IBC), excluding Chapter 27, and including Appendix A, B, C, D, E, F, G, H, I, J and K, the 2018 International Existing Building Codes including Appendix A and B, the 2018 International Fire Code including Appendix A, B, C, D, E, F, and G, the 2018 International Fuel Gas Code including Appendix A, B, C and D, the 2018 International Mechanical Codes including Appendix A and B, the 2018 International Plumbing Code including Appendix B, C, D, E, F, and G, the 2018 International Property Maintenance Code, and the 2012 NFPA 1 Uniform Fire Code;

NOW, THEREFORE BE IT ORDAINED by the city council of the city of Kingston, that:

Section 1. The 2018 International Building Code (IBC), excluding Chapter 27, and including Appendix A, B, C, D, E, F, G, H, I, J and K, the 2018 International Existing Building Code including Appendix A and B, the 2018 International Fire Code including Appendix A, B, C, D, E, F, and G, the 2018 International Fuel Gas Code including Appendix A, B, C and D, the 2018 International Mechanical Codes including Appendix A and B, the 2018 International Plumbing Code including Appendix B, C, D, E, F, and G, the 2018 International Property Maintenance Code, and the 2012 NFPA 1 Uniform Fire Code, including the provisions for the issuance of permits, collection of fees as well as all regulations, penalties and terms contained in said codes be and the same are hereby adopted as the building codes of the City of Kingston with one (1) copy of said codes to be kept on file in the office of the City Manager.

Section 2. Section 903.2.8 of the IBC is amended to exclude all one and two-family dwellings from the requirement of automatic fire systems.

Section 3. It shall be unlawful for any person to violate or fail to comply with any provision of the codes as herein adopted by reference.

Section 4. If any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.

Section 5. The City Manager is hereby directed to cause this ordinance to be published.

Section 6. This ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect from and after the date of its final passage, the public welfare requiring it.

ORDINANCE NO. <u>18-9-11-2</u>

AN ORDINANCE OF THE CITY OF KINGSTON, TENNESSEE ADOPTING THE 2018 EDITION OF THE INTERNATIONAL RESIDENTIAL CODE (IRC)

WHEREAS, the city council of the city of Kingston has heretofore adopted the International Residential Code, 2006 edition, as and for the building code for the city; and;

WHEREAS, the city council finds that it is in the best interest of the city and its citizens to adopt the International Residential Code, being designated as the 2018 International Residential Code excluding chapters 34, 35, 36, 37, 38, 39. 40, 41, 42, and 43, and including Appendix A, B, C, F, G, H, J, L, N, P, Q, R, S, and T as published by the International Code Council, for regulating and governing the construction, alteration, movement, enlargement, replacement, repair, equipment, location, removal and demolition of detached one and two family dwellings and multiple single family dwellings (townhouses) not more than three stories in height with separate means of egress as herein provided.

NOW, THEREFORE BE IT ORDAINED by the city council of the city of Kingston, that:

Section 1. The 2018 International Residential Code excluding chapters 34, 35, 36, 37, 38, 39, 40, 41, 42, and 43, but including Appendix A, B, C, F, G, H, J, L, N, P, Q, R, S, and T as published by the International Code Council, but as hereafter modified and amended, be and is hereby adopted as well as all regulations, penalties and terms contained therein with one (1) copy of said code to be kept on file in the office of the City Manager.

Amendments and modifications:

- 1. Table N1102.1.2 found on page 480 of the 2018 IRC Chapter 11 Climate Zone 4 except marine is amended as follows: Fenestration U-factor shall be 0.35; Ceiling R-value shall be 38; Wood frame wall R-value shall be 13.
- 2. Section N1102.4.1.2 (R402.4.1.2) Testing & N1103.3.3 (R403.3.3) Duct testing are deleted in entirety without replacement.
- Section 2. It shall be unlawful for any person to violate or fail to comply with any provision of the code as herein adopted by reference.
- Section 3. If any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.
 - Section 4. The City Manager is hereby directed to cause this ordinance to be published.
