RESOLUTION NO. 18-12-11-1

A RESOLUTION TO AUTHORIZE THE ENGAGEMENT OF COUNSEL TO PURSUE LEGAL ACTION AGAINST PARTIES RESPONSIBLE FOR DAMAGES TO THE CITY OF KINGSTON AND ITS CITIZENS

WHEREAS, it appears that true nature of the damages and effects of the 2008 ash spill were concealed by the parties responsible for the incident and the subsequent attempts to ameliorate the impact on the community; and,

WHEREAS, the impact of the ash spill upon the city of Kingston and its citizens continues; and,

WHEREAS, it appears that the Roane County Commission has decided to pursue investigation and legal action against the responsible parties; and,

WHEREAS, the city council of the city of Kingston finds it to be in the best interest of the city and its citizens to join with Roane County in a claim for damages.

NOW THEREFORE BE IT RESOLVED that the Mayor be, and he is hereby authorized to engage outside legal counsel, providing for an agreement expending up to Eleven Thousand Dollars (\$11,000) and allowing legal counsel a contingency fee of Twenty Percent (20%) of damages recovered, with the city paying related actual expenses and that said legal counsel shall be authorized to file suit as needed against Jacobs Engineering and/or TVA or any other responsible party for the damages to the city of Kingston and its citizens.

This resolution shall take effect upon final passage, the public welfare requiring it.
