The Kingston City Council met in regular session on Tuesday, July 13, 2021 at 6:00 p.m. Mayor Tim Neal called the meeting to order. City Attorney Jack McPherson gave the Invocation and Council Member Jeff Griffis led the pledge. Discussion included the following topics: \$500 fee requested from the Roane County Heritage Commission for electricity costs during the event (Member Stockton advised on August 7, 2021 the Heritage Commission met and voted to waive this fee), Approximately \$2500 of electrical improvements being made on the grounds of the Heritage Commission provided by the City to prevent us from having to install temporary electrical service for each event (This work will benefit not only the City during the festivals but also the Heritage Commission for their future events), Construction timeline for the brick patio project and previous verbal agreements.

Council requested that the City Manager begin discussions with the Brian Collins, Chairman of the Heritage Commission, about implementing a user agreement between the two entities.

Memorandum

The Finance Department for the City of Kingston would like to ask the City Council to vote on the Ordinance No. 21-09-14-01, amending the Annual Budget for the 2021-2022 fiscal year. This amendment will allow for capital expenditures to be allocated from the upcoming loan proceeds that the City is due to receive as well as allocate money to be used by the fund balance for capital items.

The first part of the amendment is for the loan proceeds we are to receive in the amount of \$2,500,000. The Finance Department would like to add that revenue to our budget to off-set the new allocations for capital. Those capital items will include ballfield lighting; track resurfacing; a fire truck; traffic light improvements; a community center roof; Fort South West Point, T-dock and Foot bridge improvements; a Fire Hall roof; a Bobcat for Public Works and sidewalk additions and improvements. As you have discussed many times before, these are projects that must be done and were agreed upon when making the agreement with Cumberland Securities.

The second part of this amendment is to allocate \$350,000 of the fund balance to use for the agreed upon capital projects of three Park & Rec trucks, three vehicles for the Police Department and radios for both the Police and Fire Departments.

The third part of this amendment is to include the Direct Appropriations Grant proceeds of \$80,579 to the Capital Fund to be set aside for use to be determined at a later date.

The last and final portion of this amendment is for a grant the Police Department received from Tennessee Highway Safety Office in the amount of \$6,244. The purpose of the grant is to provide extra money to staff officers for writing citations for safety violations as well as equipment used. The money needs to be allocated to cover additional salary expenses and radars purchased by the Police department as a reimbursement to those expenditures used.

The Finance Department would like to ask for your vote on this amendment so that we can continue to conduct our business as we move forward with these new allocated funds to make great strides and improvements for many of our city's departmental needs.

ORDINANCE NO. 21-09-14-01

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR THE CITY OF KINGSTON, TENNESSEE FOR FISCAL YEAR 2021-2022

WHEREAS, Tennessee Code Annotated Title 9 Chapter 1 Section 116 requires funds first be appropriated before being expended and that no appropriations may exceed available funds;

WHEREAS, Tennessee Code Annotated Title 6 Chapter 56 Section 208 allows amendment of the budget ordinance in the same manner as any other ordinance may be amended;

WHEREAS, sufficient funds were not appropriated for the library, and new funds have been received for fire and park expenditures for the fiscal year as noted below;

NOW, THEREFORE BE IT ORDAINDED by the City Council for the City of Kingston, Tennessee, that:
