ORDINANCE NO. 22-04-12-01

AN ORDINANCE AMENDING THE "ZONING MAP OF KINGSTON, TENNESSEE" BY REZONING PROPERTY FROM R-1 RESIDENTIAL DISTRICT TO R-2 RESIDENTIAL DISTRICT

WHEREAS, the Kingston City Council, in accordance with Section 13-7-204 of the *Tennessee Code Annotated*, may amend the zoning ordinance and the "Zoning Map of Kingston, Tennessee;" and

WHEREAS, at its March 15, 2022 meeting, the Kingston Municipal Planning Commission recommended that the "Zoning Map of Kingston, Tennessee" be amended by rezoning property, as identified in Section 1 and the attached map, from R-1 to R-2.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Kingston, Tennessee:

Section 1. Parcel 105.00, Roane County Tax Map 058 and Parcel 003.00, Group A, Roane County Tax Map 058E, as depicted on the attached map, is hereby rezoned from R-1, Residential District to R-2 Residential District.

Section 2. This Ordinance shall take effect from and after its passage, the public welfare requiring it.


