#### **ORDINANCE NO. 22-12-13-01**

# AN ORDINANCE TO AMEND THE KINGSTON MUNICIPAL CODE TO INCREASE THE COMPETITIVE BIDDING AMOUNT FROM \$25,000 TO \$50,000

WHEREAS, it appears that Public Chapter No. 1016 amended TCA 12-3-1212 relative to the thresholds for competitive sealed bids; and,

WHEREAS, City Council of the city of Kingston finds it to be in the best interest of the city and its citizens to increase the amount of formal sealed bids to be obtained be raised from \$25,000 to \$50,000.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KINGSTON THAT:

- Section 1. That the section of the Kingston Municipal Code of the City of Kingston dealing with amount of formal competitive bidding is hereby deleted and the following is adopted in the place.
- **5-501.** <u>Bidding required.</u> (1) Public advertised and competitive bidding pursuant to *Tennessee Code Annotated*, § 6-56-301 is required for all purchases by the city to which said statutes apply.
- (2) Formal, sealed bids shall be obtained in all transactions involving the expenditure of fifty thousand dollars (\$50,000.00) or more, and any transaction involving the expenditure of fifty thousand dollars (\$50,000.00) or more shall be evidenced by a written contract submitted to and approved by the city council.
- Section 2. This ordinance shall take effect upon passage. Any ordinance in conflict with this ordinance is hereby repealed.

## **PUBLIC CHAPTER NO. 1016**

#### **SENATE BILL NO. 2489**

AN ACT to amend Tennessee Code Annotated, Section 12-3-1212, relative to thresholds for competitive sealed bids.

#### BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 12-3-1212, is amended by deleting the section and substituting:

- (a) Notwithstanding another law to the contrary, a county, municipality, utility district, or other local governmental entity having centralized purchasing authority with a full-time purchasing agent may, by resolution or ordinance of its governing body, increase the threshold over which public advertisement and sealed competitive bids or proposals are required to an amount not to exceed fifty thousand dollars (\$50,000) for nonemergency, nonproprietary purchases.
- (b) Notwithstanding another law to the contrary, a county, municipality, utility district, or other local governmental entity having non-centralized purchasing authority may, by resolution or ordinance of its governing body, increase the threshold over which public advertisement and sealed competitive bids or proposals are required to an amount not to exceed twenty-five thousand dollars (\$25,000) for nonemergency, nonproprietary purchases.
- (c) At least three (3) written quotations are required when possible for purchases costing less than the bid threshold established under subsection (a) or (b), but more than forty percent (40%) of such bid threshold or some lower amount as may be established by the governing body in a resolution. Purchases of like items must be aggregated for purposes of the bid threshold.
- (d) For purposes of this section, a "full-time purchasing agent" means a person who devotes the whole of the person's working time to the demands and duties of the office of purchasing agent.

SECTION 2. This act takes effect upon becoming law, the public welfare requiring it.

**Section 1**. Chapter 4, Section 11-407. C-1, General Business District, sub paragraph 1.a Permitted Uses and Structures. is hereby deleted in its entirety, to be replaced with the following language:

11-407.C-1, General Business District. 1. Permitted Uses and Structures. a. All uses permitted or permitted on review in the R-1, R-2 or O-1 Districts.

Section 2. This ordinance shall take effect upon final passage, the public welfare requiring it.

#### ORDINANCE NO. 22-12-13-03

# AN ORDINANCE TO AMEND THE KINGSTON CITY CODE RELATIVE TO THE NUMBER OF MEMBERS ON THE MUNICIPAL PLANNING COMMISSION AND THE TERMS OF OFFICE FOR THE COMMISSION MEMBERS

WHEREAS, the City Council of Kingston, Tennessee, in accordance with Section 13-7-105 of the *Tennessee Code Annotated*, may amend the Zoning and Land Use Control of the Kingston City Code.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KINGSTON THAT:

**Section 1.** Title 14, Chapter 1, Section 14-101. Creation and Membership is hereby deleted in its entirety, to be replaced with the following language:

14-101. Creation and membership. Pursuant to the provisions of Tennessee Code Annotated, § 13-4-101, the City Council has heretofore created a municipal planning commission, hereinafter referred to as the planning commission. From and after January 1, 2023, membership of the municipal planning commission shall consist of eight (8) members until the expiration of the term of the sitting member whose term shall expire in calendar year 2023, at which time, the commission shall be composed thereafter of seven (7) members. One (1) member shall be the mayor of the municipality and one member shall be a councilman selected by the city council. The terms of the mayor and the member selected from the city council shall run concurrently with their terms of office on the council. The other five (5) members shall be appointed by the mayor and shall serve for a term of four (4) years, provided however, the mayor shall have the authority to remove any appointive member at his pleasure. All members of the planning commission shall serve without compensation. All members appointed prior to January 1, 2023 shall be eligible to continue to serve for the balance of their original term of eight (8) years and to be reappointed at the expiration of their term for additional successive four (4) year terms without regard to any residency requirements. From and after January 1, 2023, all other members appointed to serve shall be residents of the City of Kingston and shall serve for a term of four (4) years. Any vacancy in an appointive membership shall be filled for the unexpired term by the mayor.

**Section 2.** This ordinance shall become effective from and after its passage, the public welfare requiring it.

# AN ORDINANCE TO CHANGE THE NAME OF EAST LOVELISS STREET TO JACK MCPHERSON WAY

WHEREAS, Tennessee Code Annotated §7-86-127 provides that the authority to name public and private roads and streets, including roads and streets located within residential developments, and to assign property numbers relating to the roads and streets, is exclusively vested in the legislative bodies of counties for unincorporated areas, and municipalities within their incorporated boundaries.

WHEREAS, Chapter 16, Section 16-113 provides that names of streets in the City of Kingston shall remain as shown on said map unless officially changed by specific ordinance.

**NOW THEREFORE, BE IT ORDAINED** by the City Council of the City of Kingston, Tennessee that:

Section 1. That the name of East Loveliss Street in Kingston, Tennessee be changed to Jack McPherson Way.

Section 2. That a request be sent to the 911 Board for approval upon passage.

Section 3. That this ordinance shall take effect upon passage and approval by the 911 Board.

# AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR THE CITY OF KINGSTON, TENNESSEE FOR FISCAL YEAR 2022-2023

WHEREAS, Tennessee Code Annotated Title 9 Chapter 1 Section 116 requires funds first be appropriated before being expended and that no appropriations may exceed available funds;

WHEREAS, Tennessee Code Annotated Title 6 Chapter 56 Section 208 allows amendment of the budget ordinance in the same manner as any other ordinance may be amended;

WHEREAS, Allocations are made to cover American Rescue Plan purchase of cameras for the police department. Appropriations have been made to allow for an increase in grant revenue which is a reimbursement to Police overtime and equipment maintenance. Other revenues have been increased for auctioned off equipment to allow for the purchase of new replacement equipment and the money is being reappropriated;

NOW, THEREFORE BE IT ORDAINED by the City Council for the City of Kingston, Tennessee, that:
